- c. - e. <u>Planning Commission Appointment:</u> Appoint Arlen Mummau to the Planning Commission to fill the remainder of the term vacated by Richard Gates. (Term to expire December 31, 2023.)
- f. Year 2021 Annual Audit: Authorize the Township Secretary's preparation and placement of a legal notice pursuant to Section 917 of the Second Class Township Code, i.e. Act of May 1, 1933 (P.L. 103, No. 69), reenacted and amended November 9, 1995 (P.L. 350, No. 60), as amended, for the appointment of White, Rudy LLC, 436 Cloverleaf Road, PO Box 188, Elizabethtown, PA 17022, as Mount Joy Township's independent certified public account firm to perform the annual audit of the Township's records for calendar year 2021, as per the letter dated October 12, 2021 establishing the compensation to be paid at \$12,900.00, with action scheduled to be taken at the December 15, 2021 meeting; and 2) authorize the Chairperson of the Board of Supervisors to sign the engagement letter from White, Rudy LLC, whereby the scope of the annual audit to be performed of the calendar year 2021 records is set forth.
