- a. Approve and ratify the minutes of the August 15, 2022 meeting.
- b. Approve payment of all bills via Bill List #17-2022 in the amount of \$157,458.14; Bill List #18-2022 in the amount of \$8,055.71; and Bill List 19-2022 in the amount of \$457,462.76; and ratify the payment of all payrolls for the period of August 12, 2022 through September 8, 2022 inclusive, in the amount of \$46,485.47, which represents two pay periods.
