**Re: PPL Electric's Recommendation on the Interconnection Agreement
Application of SUNN 1020 LLC Docket No. M-2026-3059589**

Dear Mr. Shafer:

On May 28, 2026, PPL Electric Utilities Corporation (PPL) submitted to the Pennsylvania Public Utility Commission (Commission) a proposed Interconnection Agreement between PPL and the applicant, pursuant to 52 Pa. Code § 75.13(a)(5). Pursuant to 52 Pa. Code § 75.17, which describes the process for obtaining Commission approval of customer-generator status for net metered alternative energy systems with a nameplate capacity of 500 kW and greater, PPL included the results of its review and recommendation regarding the application in its filing. The Bureau of Technical Utility Services is authorized to review the submission and issue a determination recommending approval of a net metering application under 52 Pa. Code § 75.17(e). Accordingly, the Bureau of Technical Utility Services determines that the recommendation to approve the eligibility of customer-generator status and the

Net Energy Metering application noted above complies with 52 Pa. Code Chap. 75 and the utility's tariff. Therefore, the Bureau of Technical Utility Services approves this net metering application. The approval contained in this Secretarial Letter is limited to the public utility, customer, and alternative energy system specifications included in the submission.

Any subsequent changes that may relate to customer virtual meter aggregation, or which result in an increase to the nameplate capacity of the alternative energy system described in the Application will require the filing of a new application consistent with 52 Pa. Code § 75.17(e). Additionally, the Bureau of Technical Utility Services requests that any other changes to the proposed alternative energy system be identified and submitted to the Commission within thirty (30) days of installation of the alternative energy system.

Petitions for appeal from this Secretarial Letter must be filed within 20 days after service of this Secretarial Letter in accordance with 52 Pa. Code § 5.44.¹
